

Terms and conditions for running the WET canteen are attached herewith. Last date of receipt of the quotation is 05<sup>th</sup> Oct. 2017 (up to 1600 hrs). **The highest bidder of canteen rent per month under the terms and conditions will get the contract.** Quotations are to be sent by Registered/ Speed post only. The quotations will be open on 06<sup>th</sup> Oct. 2017.

**TERMS AND CONDITIONS:**

1. The contractor must have the registration under Food Safety and Standards Act of India (FSSAI).
2. The timing of the canteen should be from 0800 hrs to 1400 hrs for students and from 0800 hrs to 1430 hrs for staff.
3. The contractor will have to pay rent, electricity and water charges on or before 15<sup>th</sup> of every month.
4. The Contractor will have to keep the canteen and surroundings neat and clean.
5. No gutka, pan, tamul and cigarette etc. are allowed in the school premises.
6. The prices for the various edibles will not change and they should be same as per the quoted price. The price will not be higher than the market price.
7. The contractor will have to display the price list of the edibles /items at two places.
8. Only hygienic food materials as per the list quoted will be sold and will have to prepare with hygienic standard edible oil.
9. The premises let out to the contractor will not be allowed to be used for any other purpose including residential by the contractor or his employees.
10. Contractor shall have to submit his police verification reports along with his employees.
11. The contractor shall have to deposit a sum of Rs. 5000/- (Rupees five thousand only) as security deposit and the same will be refunded within one month after the expiry of contract, it will be forfeited in case of breach of any of the conditions laid down.
